AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR MONTRACHET, OVERLAND PARK, KANSAS

This Amendment is made as of this 10ⁿ day of seconder, 2017 by Montrachet Home Owners Association, Inc., a Kansas not-for-profit corporation (hereinafter referred to as "Association").

WHEREAS, Oakbrooke Associates, as Developer, on September 24, 1986, adopted a "Declaration of Covenants, Conditions and Restrictions for Montrachet, Overland Park, Kansas" (hereinafter referred to as the "Declaration"), pertaining to the real property more fully described on Exhibit A attached hereto and incorporated by reference. The Declaration was recorded in Johnson County, Kansas on September 29, 1968 in Vol. 2432, Page 200; and

WHEREAS, the undersigned, being more than 75 percent of the members of Montrachet wish to amend the Declaration to clarify the manner of repairs to exterior stucco walls;

NOW, THEREFORE, in consideration of the premises, the undersigned, for themselves and their heirs, representatives, successors, grantees and assigns, hereby agree that all of the lots, tracts and land shown described in Exhibit A shall be and they are hereby restricted as to their use in the manner hereinafter set forth and the Declaration applicable to said property only is hereby amended and supplemented as follows:

This Amendment shall become effective as an Amendment of the Declaration and binding upon all of the Lots upon the recordation hereof in the office of the Johnson County Register of Deeds.

Article V is amended by adding the following provision:

"When exterior stucco is repaired, if necessary, the entire wall shall be painted to match the existing stucco on the remainder of the structure."

Except as otherwise amended hereby, the Declaration will remain in full force and effect.
